**7. Matters from the February meeting**

- Dario has been in contact with Stefania and she confirmed that she is available for the classification team at the E&A Disabled Championships in Fischlham.
- Dany has followed up with the Belgian disabled rider request for information on wakeboard.

**8. Calendar 2022/2023**

- E&A Championships 2022  
Classification Team:  
Both Stefania and Bethan have confirmed they will go to Austria, along with Christophe as the athlete representative so we have a full Classification Team confirmed.  
Christophe will bring the wobble board, he will also buy a medicine ball.  
Dany will bring a CAS and ask the Italian Federation if they can bring their CAS as a spare.

12. **Progress/development**

- CAS  
An Audio Slalom System (CAS) for the Disabled Council has been ordered. It hasn't be delivered yet. The price will be 1500 Euros.

14. **Matters from/to IWWF Disabled Council**

- Vision on the future for Disabled Waterski
- We are hoping to change the classification process in the rules for visual impaired skiers. The proposed change would allow V skiers to be tested independently of a titled event, making it easier for them to know their classification. As soon as changes are agreed they will be reflected in the handbook.

15. **Disabled Cable Wakeboard**

- Philippe proposed a disabled representant to the Cable Wakeboard Council, but they have found another candidate. Cable Wakeboard would like to have classification in every country in the same way as snow skiing. This will be a lot of work, but they will need to make their own decisions about categories etc and what works best for them.

- Carmen found some differences between our old system and the EMS. This will be taken care of. Dany is not allowed to update national officials, so we have to contact the national federations, so they can do necessary updates if needed.
