Registration to close soon, as max participants is almost reached – Maximum 5 ski teams can participate in 2022 Chris to share information with Steve Bird – info to be posted on RC website.

#### 11. Bids for 2023 World Championships - options

No firm bids received sofar. Initial intention of Teneriffe still pending – however prior to being able to move forward we need to help resove issue between Teneriffe - and Spanish Federation.

RC to act as mittigator (Richard and Chris to follow up with Secretary Canarias and Chairman of Spanish Federation) Australia and US teams have expressed they prefer to have WC held in Europe, this to maximize the number of competitors attending.

# 12. European Racing Hall of Fame.

As we did not award the 2019/2020/2021 candidates, we decided in June 21 meeting to keep the same names and award them in 2022:

- Carlo Cassa (ITA) European Champion F1 Men 1996 2002
- Miriam Grignani (ITA) European Champion F1 Women 1984 1985

#### 13. Revision of any Region Europe Racing rules for 2022

Changes to rule 6.06 – wetsuits skiers

Final text is available – Vera to share updated version – rule to apply in Europe as from 2023.

Updated European rules to be published soonest.

#### 14. Boat Numbers

2019 was collected

2020 & 2021 exemption of payment due to Covid

2022 back to normal procedure – billing to Federations will follow by latest November.

Thea to share the list with Chris and Steve.

Chris to address Canarias in regards to use of numbers belonging to other countries and to urge Canarias to comply with the correct boat number procedure.

#### 15. Region Europe Racing nominees for IWWF Hall of Fame- new selection process.

The process in itself has not changed, the only changes to be noted are the actual SELECTORS that have changed.

Selectors for Racing are: Meryl Lee (AUS) - Mike King (USA) - Tom Lumley (GB)

Powerpoint presentation and procedure was shared with RC members.

#### 16. Discussion on possible future formats/formulae of Water Ski Racing in Europe

As the pressure on moving to a carbon neutral world is an actual hot item, we need to consider how we can reduce Racing footprint. A separate committee is to explore options and create report.



(for this we need to involve teams, boat contructors any and all that have ideas on "sustainability" for our sport) Steve B/Steve C and Richard H will be taking the first initiatives.

#### 17. Any other business

GBR issues seem to continue - GBR will no longer be sanctioning any races.

GBR Skiers that participate in non sanctioned racing are not eligible for International license.

GBR federation no longer wishes to support Ski Racing as cannot provide adequate/acceptable insurance for Ski Racing. This seems to have become an endless story whereby the GBR federation iso trying to resolve the issue has decided it was easier to tell Ski Racing they are on their own.

As EC, we cannot get involved in these domestic matters. However, it is wishful to help mittigate from Admincom side. Work in progress, to be continued and hopefully resolved.

LAO Beringen was not fully accepted by Admincom in the submitted format and requires some tweeking.

The relevant obligations to be revisited/discussed with Beringen and RC.

Steve B expresses his excitement on being newly elected to the RC and looks forward to working together with the RC team.

#### 18. Date and venue of next meeting.
