Dear Friends,

Following our previous letter of March 2011 informing you of the possibility of funding for preparing your athletes for the 2011 season and for the next 2013 Mediterranean Games, we have the pleasure to advise you of the details of the Training Camp for Young Skiers.

This training camp is being organised for young skiers (under 12) whose target is to take part in the Topolino Trophy in Omegna, Italy, 2 - 4 September 2011. E&A will pay full board and coaching for skiers (except the following countries: Italy, Spain, France, and Greece) for this training. The Federations will have to pay for travel to, from and on the site. E&A will cover expenses up to the maximum of 3 athletes per country.

B - Mandatory process to be followed:

A- For “pre-Topolino” training camp:

- a. Each federation has the responsibility of selecting skiers/riders and communicating (maximum 3 persons).

- and inform E&A (Development Commission).
- c. Each federation will make their own hotel booking and pay for it. E&A will refund full board upon receipt of invoice (to be sent to E&A Development Commission).
 - d. Each federation will pay the full expenses for travel.
 - e. Each federation will be notified of skiers' funding before August 5th.
 - f. If total number does not exceed 15 skiers, extra skiers in addition to the 3 allocated to each country can be added at their own expense.

B – For Topolino competition:

- a. Each federation has the responsibility of selecting skiers/riders and advising these.
- b. Each federation has the responsibility of making their own reservations and entry form for the Topolino Trophy. The bulletin will be sent by the Italian Federation.
- c. Each federation will pay the full expenses for travel and lodging.

NOTICE: Federations concerned: Croatia, Lebanon, Monaco, Serbia, Turkey, Israel, Egypt, Cyprus, Malta, Morocco and Tunisia.

ATTENTION: Deadline for requesting refunds for the camp should be received by E&A (Development Commission) before October 1st 2011.
