 - c. Peter would like to go live with CWB April 2020, Suzi has asked for a benefits study to be produced to help explain the new costs to athletes.
 - d. Shannon, charging for riders, suport for software, support from IWWF. See's it works ok for WWA, and is accepted by the riders.
 - e. Javier not many events in Panam
 - f. Dean Riders need to know its mandatory.
 - *i.* Next steps Peter is working with Lucien to ensure we do not lose any integrity from existing systems.

- 4. New Bulletin Template
 - a. Suzi has created a new mandatory bulletin template to help hosts create information for their events, this is needed because a lot of sites have had significant information missing from bulletins.
 - b. Idea is Competitions will only be registered once the Bulletin has been created, and sent into the Office.
 - c. Bulletin Template passed by: Varna, Walter, Seb, Jerox, Shannon, Suzi & Manuel
- 5. Registration Form to have cancellation policy added.
 - a. Suzi to update form.
 - b. This is required because we had three cancelled competitions this year.
 - c. Passed by: Varna, Manuel, Shannon, Javier, Seb, Suzi, Jero
- 6. Double Entry / Split Competitions
 - a. It was explained that there are NO Double Entries, as this is against the rules. However for sites wishing to split events, they must detail this in the bulletin and recognise, that they will be charged for registering both competitions, the only exception this is when registering a 'Minis' Comp at the same time as an International Competition to allow younger riders to participate.
- 7. Events:
 - a. Mexico Jero mentioned he had an issue with registering Nationals for Mexico, and that he was having problem getting the NGB to sanction. SN said happy to write to Mexican Federation to ask if they needed any assistance with running the Nationals.
 - b. 2020 Europeans, till negotiating with host sites.
