Disabled skiers do not currently have to pay for the EMS license if they only compete in disabled competitions.

The Greek (Hellenic) Federation does not have a CAS available, Norway will probably bring theirs and make it available to the organisers.

The starting dock will be accessible for wheelchairs. There are some steps there, but they will be covered by a ramp. The jury tower will not be accessible.

Since the Championships are combined with the Open Championships, the disabled skiers will have to pay for the familiarisation.

Candido is working on the schedule.

Christianna was informed about the special needs for the disabled competition:

- Room for classification
- Wobble board
- o Inner course
- o Ramp height down to 1.25m

Christianna will contact Christophe if she has any questions.

It is possible to postpone the Championships to September if there are still travel restrictions in the summer.
